International Coffee Council 137th Session 19 March 2024 London, United Kingdom Statement by the Chair of the International Coffee Council, Dr Enselme Gouthon, made at the opening ceremony of the 137th Session of the Council

Your Excellencies,

Distinguished delegates,

ICO Executive Director,

Ladies and gentlemen,

First of all, I would like to extend a warm welcome to you all to this 137th session of the International Coffee Council and to thank you for taking time out of your schedules to attend this online meeting.

In September 2023, at the 136th session of the Council in Bangalore, India, I had the honour of being elected as Chair of the International Coffee Council (ICC), with the support of all of you, to lead our deliberations and promote our activities during coffee year 2023/24.
